Drury Taylor, Sr., was the ninth of William, Sr. and Martha (Patty) Taylor's ten sons. He was born in 1788 after the family had moved to Georgia from South Carolina (from the Georgia Archives). William Taylor, Sr. received a six hundred acre land grant on Big Coldwater Creek in what is now Elbert County, Georgia, in 1784. The area is now covered with the back-up waters from the Russell Dam which was built on the Savannah River.

The only way that we were able to determine Drury's year of birth was because he had signed a deposition in 1838 where he listed his age as 'about fifty years old'. This deposition was found in the Smith County Court House in Tennessee.

About 1814 Drury married eighteen year old Elizabeth Dupree. The Duprees (or DuPrees) were French Huegenots that may originally have come from Manakin Town, (Goochland/Henrico Counties) Virginia.

There is a book, *The Dupree Trail* by Langley which states that the Duprees came from Brunswck County, Virginia to Pitt and Edgecombe Counties of North Carolina. There are several land transactions from about 1767 documenting their stay there until they started taking up land in Davidson County, Tennessee, in the 1790's.

The following deed proves that some of the Duprees were also in Georgia at one time.

Wilkes Co., Georgia, Reality Book C page 121 Aug. 16, 1790, Thomas and Henrietta McCall of Augusta to Reed Dupree of Greenville County, VA, 200 acres, tract of land lying in county of Wilkes on the fork of Coldwater Creek.

Reed Dupree, the son of Lewis Dupree, Sr., had a brother named James. It appears that this is the James Dupree of Davidson County, Tennessee, who was the father of James C. Dupree and Elizabeth Dupree Taylor.

James Dupree's will was dated July 6, 1819, and proven in October of 1819 in Williamson County, Tennessee. He had married his second wife, Nancy Nichols, on December 12, 1798. James Dupree had the following children: James C.; John H.; Minerva; Amanda; Sarah; and Elizabeth.

On November 24, 1833, James C. Dupree gave Drury Taylor power of attorney to sell his land on the north side of Caney Fork in Smith County, Tennessee. This, Drury did in March of 1841. (See page 43 of Taylor Legends)

The first record we have been able to find for Drury Taylor obtaining land in Indian Creek was on November 15, 1814, when he bought one hundred acres from Patrick McEachern. The deed indicated that Drury was already living there before this time. He had come to what is now DeKalb County, Tennessee, from Elbert County, Georgia, with the William Taylor, Sr. migration in about 1806

Drury later bought a tract of land on the west side of Caney Fork from the heirs of Samuel Hall. This is found in Deed Book M, page 167 - 168 and dated February 24, 1829. He sold this parcel of land on March 22, 1841, to Henry R. Taylor and moved his family to Jefferson County, Illinois. (See page 44 of Legends)

There are a couple of land transactions in Jefferson County, Illiois, involving Drury Taylor that remain a complete mystery to me. The land in question was originally part of a land grant given to Jacob L. Taylor on May 21, 1839, in Blissville Township. To date I have not found any record of how Drury acquired the land from Jacob before he sold it back to him on October 9, 1844. The transactions are as follows:

The forty acres that Drury bought for five hundred dollars was a portion of the one hundred twenty acres that Drury sold Jacob ten days earlier for some eighty dollars. The reason behind this is unknown. I can find no transaction showing how Drury acquired this land in the beginning. At the present time we have no proof as to who Jacob L. Taylor might be or the witness, Lydia Taylor.

It is also possible that this is the same forty acres Elizabeth Taylor sold in 1855 for \$100 to Benjamin [Hironson, spelling questionable]. In the information that I received there was no description of the land to help identify where it was located.

Blissville Township is located in the southwestern portion of Jefferson County. It borders Washington County on the west and Bald Hill Township on the south. Bald Hill borders Perry County on the west and Franklin County on the south. It appears there is only one town in the township, Waltonville, located beside the Norris Branch in the very southeast corner of the township (section 36). In 1973 it had a population of three hundred ninety-four people.

It appears that Blissville was settled by land grants but I do not know what people had to do to obtain them. There were three hundred eighty-two grants made between the years of 1833 and 1895. There were two Taylors that obtained land grants; Benjamin who F. Taylor on March 7, 1839, received forty acres in Section 27 and again on January 8, 1839, he received eighty acres in Section

21. Jacob L. Taylor also received two grants, one in Section 10, the other in Section 20 for a total of one hundred twenty acres on May 21, 1839. How these two men were related to Drury is unknown, although we believe they were. We have found neither on any census records. $-\frac{1840}{2}$

If Drury lived in Section 10 as we believe, he was about nine or ten miles from Mt. Vernon, the county seat of Jefferson County. Novak Creek passes through the middle of the acreage in Section 10. There is no one living on this property at the present time.

By August of 1844 Drury, Sr. had taken ill, with what we cannot tell from the doctor's notes, although some of the charges were for 'blood letting'. It appears the doctor made forty-two visits to his home before Drury died on March 6, 1845. The doctor's bill came to \$100.17.

Drury's wife, Elizabeth, was appointed administrator. She made an oath stating that Drury died intestate on the 6th day of December, 1845. Included in the estate notes we found the following:

`March the 16 AD 1846

`Downing Baugh sir I am unwell at present and not able to ride to town I am willing to go my mother's security as administrator of the estate of my father and if it will do enter my name as such This is to authorise you to do so

`Adolphus Leander A Tailor'

There is another paper that indicated that Elizabeth Taylor, Adolphus L. A. Taylor, Oringe Griffeth, and Godfrey Taylor had to swear to make bond for the settlement of the estate.

Patsy Taylor was called to testify in a lawsuit against her mother by Abner Caldwell during the estate settlement. He had earlier submitted a bill that was owed him by Drury Taylor. The records that we received did not state the amount of the bill, what it was for, or the out come of the lawsuit. Patsy later married Samuel Quinn, one of the appraisors for Drury' estate.

"State of Illinois Jefferson County

The people of the state of Illinois to Patsy Taylor Greeting: You are hereby commanded to appear before me at my office in Mt. Vernon on Tuesday the 5th ____t at 12 o'clock all then and there to testify and the truth to speak in a certain matter wherein Abner Caldwell is plaintiff and Elizabeth Taylor administrator of Drewry Taylor desceased is defendant. Herein fail not under the penalty of the law.

Given under my hand and seal this 4th day of May, 1846 D. Baugh'' There was also a list of debts that were owed to Drury Taylor, Sr., some of the writing was not too legible. They were as follows:

William W. Taylor of Jefferson County, Missouri, note due about June 1842 for \$146.00. One note on Abalon Hopper, due about 1838 for \$39.00 Judgement on Wm. Page adm. for Nancy Gordman (doubtful) for \$17.00 Note on Nathaniel Swell for \$9.00, supposed to be good.

Now-- who was this William W. Taylor? In March of 1839 a William W. Taylor was appointed, along with several other Taylors, to help build a road in Indian Creek. It also had George Taylor as another road hand. In July of 1840 George Taylor was again appointed to help build (probably finish) the same road. William W. Taylor was not among those on this list. The 1839 appointment was the only time that we found William W. Taylor on any of the DeKalb County Court records. George Taylor has only been found on the two lists. Since they were listed together and it was a common practice to appoint all capable hands that lived near the road to be built we are of the opinion that William W. Taylor was probably a son of George Taylor, another of Drury's many brothers.

There is another scrap of paper with the following on it:

August the 16th 1847 Drury Taylor in to William Taylor - Seventy five dollars for 1 mare (remainder is not readable).

Since Drury died in 1845 and his son Drury M. was only nine years old at this time I'm at a loss as to who this might be, unless this William was one of Drury, Sr.'s nephews who simply wanted to help the family out.

The following is the result of the inventory and appraisal of the property of Drury Taylor by Jesse P. Dees, Oringe Griffeth, and Samuel Quinn, taken the 21st day of March, 1846.

Elizabeth Taylor and her younger children are found living together on the 1850 census of Jefferson County, Illinois. In 1860 according to the Ste. Genevieve County, Missouri Census, Elizabeth, her daughter, Elizabeth and her husband, William Wyatt, Matthew, his wife Eliza, Duane M., his wife Sarah, Drury M., his wife Mary, and John, were living in Union Township, Ste. Genevieve County, Missouri. At that time Elizabeth and her youngest child, John, were living with her daughter Elizabeth, and her husband, William Wyatt.

From what we can learn from the census records it appears the family moved to Ste. Genevieve, about 1857 or 58 and were all back in Jefferson County, Illinois, by 1862 with the exception of Matthew. We have not been able to find any more records concerning Matthew or his wife since the 1860 census was enumerated. Since this was about the time that the Civil War started one can but wonder if this influenced the move back to Jefferson County.

From the 1870 census of Jefferson County we found Elizabeth living with her son John, his wife Narcena, and Sarah's three youngest sons. Sarah was Drury's youngest daughter who had died a short time before the 1870 census was enumerated. The family was still living in Blissville Township, although their address was Ashley, Illinois, which was located in Washington County. This was the last record that we have found concerning Elizabeth Dupree Taylor.

The children of Drury and Elizabeth Dupree Taylor

Drury and Elizabeth Taylor had at least twelve children. All but the youngest child, John, were born in Indian Creek, DeKalb County, Tennessee. Their children were Godfrey, Rebecca, Dempsey, Leander, Mary, Martha, Elizabeth, Matthew, Duane, Sarah, Drury M., and John.

It appears that all of Drury's children, with the exception of Godfrey and Dempsey, made the move to Jefferson County, Illinois, in 1841.

Five of Drury's children remained in Jefferson County until their deaths, Rebecca, who died in 1880; Mary in 1897; Martha in 1903, Sarah, sometime during the late 1860's, and Drury M. in 1870. We have been able to find some of their graves, others do not have markers. Many early day grave markers were made of wood and are no longer standing. There is no record of where either Drury, Sr. or his wife, Elizabeth are buried.

It appears that Godfrey moved to Perry County, Illinois about 1849 or 1850. He did not stay long as by 1854 he had again moved, this time to Camden County, Missouri. He is found on the 1860 Camden County Census under the name of Godfred M. Taylor and the 1870 as G. M. Taylor. By 1880 he was in Miller Township, Dallas County, Missouri, were the census listed him as Fred Taylor. At this time he and his extended family were living in what could be called a small Taylor community. Not only was Godfrey and his family there but also his brother Duane Marion's family as well. Duane apparetnly stayed in Illinois until 1874 at which time he moved to Arkansas, but by 1877 he too was living in Missouri. Duane died in Dallas County in 1879.

As for Leander, I can not help but wonder if he may have died during the late 1850's. Why? First I can find no trace of him after 1850 and secondly four of his siblings named a son Leander, two in 1857, one in 1859 and another in 1861. Siblings often named a son after a much loved brother after his death.

Dempsey probably moved to Pope County, Arkansas, about the same time that the rest of the family moved to Jefferson County, Illinois. He bought nearly one hundred twenty acres of land there in 1844. He died in 1895 and is buried in Pope County.

Apparently there was another 'migration' out of Jefferson County sometime during the 1870. Where to, we've no idea. There is the possbility that Drury's widow, Elizabeth, may have made the move also. She was seventy-four in 1870 and to date we have found no record of her death. She had been living with son John who cannot be found after 1870 along with Sarah's children, his sister and her husband, William and Elizabeth Wyatt. Neither can we find what happened to Drury M.'s widow and her children or the Throgmortons. Drury M. and Matthew married sisters, the daughters of William Throgmorton. We haven't been able to find Matthew on any records after the 1860 census.

Two of Drury's daughters married Quinns, Washington and Samuel, brothers who were born in Spartenburg, South Carolina. They also had a couple of sisters, Harriet, who married John W. Taylor and Mary who married Jacob P. Taylor. John W. was the son of Henry H. Taylor, one of Drury Sr.'s brothers. Jacob was the son of David Taylor, 1779.

It is thought that John W. may have made the move to Illinois with Drury or perhaps a year earlier. John W. died in 1842 in Jefferson County, Illinois. John W. Taylor and Harriet Quinn only had one child, a daughter, Lydia C. who was born in 1841 in Illinois. Harriet later married Philo Gilbert, and Lydia married Robert H. Green when she was only fourteen.

As mentioned before, there appeared to be a small Taylor community in Dallas County, Missouri, by 1880. In addition to Godfrey and Duane's families, John Kent Taylor and Mills Drury Taylor and families were living there, John K. in Miller Township

and Mills in Jasper Township. John K. and Mills were the sons of John T. Taylor and grandsons of John (War of 1812) Taylor and his second wife Nancy Sweeten. John (War of 1812) and Drury, Sr. were brothers.

Years ago when we first tried to find the children of Drury Taylor, Sr. we found a Drury L. Taylor, Jr. living in District 4 of DeKalb County, Tennessee. We naturally assumed that he was a son of Drury, Sr. It now appears he may have been a son of David Taylor, 1779. Drury, Sr. and David, 1779 were first cousins, both living in Indian Creek for many years. We knew that some of Drury's family had moved to Jefferson County, Illinois, but not much else. It wasn't until Neal Taylor happend upon the 1850 census of Jefferson County, Illinois, for Elizabeth Taylor and her five youngest children that were were finally able to track down Drury, Sr. and his children. It was then we discovered that one of them was named Drury M., born 1838 and not Drury L. who was born in 1815.

The use of senior and junior were used to designate an older gentlemen from a younger one. It was not necessarily used for father and son on census records.

If one checks the marriage records of Jefferson County you will find that there was another Drury Taylor who was married in the county. This Drury Taylor married Martha McLaughlin on February 21, 1867. He was the son of William and Eliza Taylor, who had moved to Jefferson county sometime during the 1850's. William was one of the younger sons of Joseph Taylor, a brother of Drury, Sr. William also had a son named William, b. 1848 and it was this William that helped Mary E. Throgmorton Taylor make bond when Drury M. died in 1870. We don't know where this Drury Taylor went either.

The first records we have found concerning Godfrey are from the Smith (later DeKalb County) court records where he was appointed as a road hand for various roads that were being built close to where his father lived in the hollows surrounding Indian Creek. He was also found on the 1830 census of Smith County and the 1840 census of DeKalb County. He had not moved, DeKalb County was carved out of Smith County in 1837. Drury and Godfrey both lived in Indian Creek until they moved to Jefferson and Perry Counties respectively. He was a witness for a power of attorney from his uncle, James Dupree, to his father involving some land that James owned in DeKalb County. He later helped make bond for his mother when his father died in Jefferson County.

The records vary on his birth day from 1815, 1817, to 1819 depending on which census record one is using. Godfrey also went by the names Godfred and Fred. Additional information can be found in William Taylor, Sr. Volume III.

Godfrey apparently did not move in 1841 to Jeffeson County, Illinois, with the rest of his family. He remained in Indian Creek until sometime between 1847 and 1849 at which time he moved to Perry County, Illinois, which is located southwest of Jefferson County. By 1854 he was living in Camden County, Missouri.

The 1860 Camden County census lists a Godfred M. Taylor, born 1817 in Tennessee. The 1880 Dallas County, Missouri, census had a record of Fred Taylor, born in 1817 in Tennessee and several members of his family including one for a grandson named Godfrey Taylor, who was born in 1877 in Missouri.

Godfrey and his extended family were living in Miller Township. Dallas County, in what could be called a small Taylor community in 1880. Not only was Godfrey and his family there but also his brother Duane's family.

In addition to some of Drury Taylor's family living in Dallas County some of Drury's brother John's family were also living John Kent Taylor and family were in Miller Township and his brother Mills Drury Taylor in Jasper Township. They were the sons of John T. Taylor and grandsons of John (War of 1812) Taylor.

Whether Godfrey ever took up land in Dallas County is unknown at this time. It is assumed he died in Dallas County sometime after 1880. No death date, probate record, or cemetery record has been found as yet.

Godfrey was married four times. He had a total of ten children; two by his first wife; two by his second; three by his third and at least three by his fourth wife.

Mills first wife was Amanda Marlow who died April 2, 1875, giving birth to Amanda Vinnie. Also missing on the census was their son, Thomas. Missouri was Mills and Jodena's daughter. Rebecca Taylor was the oldest of Drury's five daughters. She married John W. Hicks a year or two after the family moved to Jefferson County when she was about twenty-four years old.

The first census record that we found them on, the 1850, they were living in McClellan Township next to her sister Mary and her husband, Washington Quinn. By then they had three children, Isaac, James and William. John was listed as a farmer with real estate valued at \$2000.00 and personnal property at \$1000.00.

The 1860 census found them in Dodd Township, two townships straight east of Blissville Township. Rebecca is also found on the 1870 census of Dodd with her three youngest children, William, Eliza, and John. She is listed as a farmer with real estate valued at \$1000.00 and personnal property at \$150.00. Her son James and his famly were living in the next dwelling. He too was listed as a farmer with \$200.00 real estate and \$125.00 personnal property.

John Hicks had died in March of 1865 and Rebecca died on January They are both buried in the South Hickory Hill Cemetery in McClellan Township.

Some members of the Hicks family, David and Isaac, received land grants in section 1 of Blissville Township in 1852 and again in 1855. There was a Mary Taylor who married a William Hicks on July 30, 1844. I do not know how these Hicks' were related to John W. Hicks nor do I know who this Mary Taylor was.

In the beginning of our search for the children of Drury Taylor, Sr. the only records we could find concerning Dempsey were from the DeKalb County, Tennessee, court records. He, along with Godfrey, witnessed his father's power of attorney from his uncle, James Dupree in 1833. He is again mentioned as a road hand on various court records along with his brothers, Godfrey and Leander, during the 1830's.

Because of the expert help of James J. Johnston of Fayetteville, Arkansas, I now feel that I can complete the history of Drury Taylor, Sr. and his family. Mr. Johnston has helped me out before with several Arkansas Taylors for which I am very grateful. (See page 202 of William Taylor, Sr., Volume III)

Dempsey Taylor has been more than a little hard to find since he apparently had no contact with his family after 1841. Neal Taylor finally found him on an 1850 census of Pope County, Arkansas. Now with all the information that Mr. Johnston found we can finally recount a little of his life. I have not tried to trace any of his children but, Pope County has good records and it probably would not be too hard to do a fairly complete family tree.

I'm of the opinion that Dempsey may have married during the late 1830's. I am also of the opinion that he and his wife had a daughter in 1839 that they named Elizabeth and that his wife died at about the same time. As I have previously mentioned I have never been able to figure out the 1840 DeKalb Census for Drury, Sr. and his family, but I assume that Dempsey and at least his young daughter were on that census living with the family of

Drury Taylor, Sr. Young Elizabeth was still living with her grandmother in 1850 as is shown by the 1850 census of Jefferson County, Illinois. In 1860 she was living with Drury M. Taylor and his wife in Ste. Genevieve County, Missouri. Drury M. was Dempsey's younger brother.

Dempsey apparently moved to Pope County, Arkansas, at about the same time that his father moved to Illinois. Here he took up two tracts of land on July 10, 1844. There were:

E NW, Sec. 34, Twp. 8N, R 21 W, 79.92 acres SE SW, Sec. 27, Twp. 8N, R 21 W, 40 acres

Both the 1860 and 1870 census show that he was living in Clark Township while the 1880 census lists his residence as Illinois Township, all of which are located in Pope County.

For some reason we have not been able to find any marriage records for Dempsey Taylor in either DeKalb County, Tennessee, or Pope County, Arkansas. It is possible that he and Martha Garrison were married in Smith County, Tennessee, but there is no record of their marriage there either.

Cynthia R. Ray was the youngest of three children born to John and Cynthia McQuire Vawter Ray. From the Pope County History, Volume I, page 387:

"These Rays were in Lafayette Couty, Mississippi, in 1850 and in Pope County in 1851 or 1852. Cynthia R. Ray married Robert Hamilton in 1856. He died in the early 1860's after which she married Dempsesy Taylor. She passed away in the early 1870's." They had three children, Martha, James F., and Nancy.

We do not know who his first wife was nor is it known who Dempsey's fourth wife was, other than for the name of Elizabeth. It appears that Dempsey may have had a total of nine children although there may have been some that died young and are not on the census records.

Dempsey died at age seventy-five in 1895. He is buried in the Pisgah Cemetery in Pope County, Arkansas. I do not know if there is a gravestone for him or not, nor do I know if any of his wives are buried there either. It is interesting to note that on his death record no one put down the name of any of his wives, his children, or his parents.

Since I can only speculate on what might have been I cannot help but think there may have been a family rift between Dempsey and the remainder of his family. None of the other members of his family ever named a son Dempsey nor did he ever name any of his children after any of them which was quite unusal for this family of Taylors. He did however name three of his children after his mother's brothers and sister, James, John, and Minerva Dupree.

For years we believed that Drury, Sr. had a son named Leonard since that was the name we found in the Smith and DeKalb County, Tennessee, court records. As was the custom in Indian Creek when help was needed in building a road the court appointed the men of the families living along the area where the road was to be built. Drury, Godfrey, Dempsey, and Leonard were always appointed to work together as road hands with several other Taylors and neighbors who would be living along the new road.

It was not until we found the note that Leander wrote to Downing Baugh about not being able to come to Mt. Vernon in person to go, as he put it, his mother's security as administrator of the estate of his father that we learned his true name. He had signed the note Adolphus Leander A. Taylor.

Leander was not married at the time of his father's death, but about a year later he married Frances Mitchell. He, his wife, and young son are found on the 1850 census of Jefferson County, the last record we have found concerning any of them.

I am of the opinion he may have died during the 1850's. He stated in his note to Downing Baugh that he was unwell and not able to ride into Mt. Vernon in the spring of 1846. It may have been that he was suffering from something that would eventually take his life.

Another reason for believing he may have died prior to 1860 is that his siblings started naming their sons Leander between the years of 1857 and 1861, perhaps because a well loved brother had recently died, a custom followed by many families.

Mary Taylor married Washington Quinn soon after Drury and his family settled in Blissville Township, Jefferson County. She was twenty-one when they married in 1843. Washington was born in Spartenberg, South Carolina, in 1814. His family apparently moved to Tennesse soon after as he had a sister who was born there in 1817. To date I have found no records of when they moved to Illinois, but would guess sometime during the middle to late 1830's. His brother, Samuel Quinn, received land grants starting in 1839 in Blissville Township.

From what can be determined from the probate records of Washington's estate and the census records it appears that he and Mary may have had least seven children. It appears two died rather young and only three were still living when Washington died in 1903 when he was eighty-nine years old. It seems quite possible that they may have had more children who died very young. To date we have found no Bible records of this family or a living descendant. Mary's tombstone had the inscription that she had been the wife of Washington Quinn for fifty-four years. Washington and Mary are buried at the South Hickory Hill Cemetery in Jefferson County as is Mary's sister and brother-in-law, John W. and Rebecca Hicks.

From the census records it appears the Quinns lived in McClellan Township for most of their lives. McClellan Township is located straight east of Blissville. The census records indicate that Washington was a very suscessful and prosperous farmer. On the 1860 census he had real estate valued at \$6800.00 and personnal propety at \$2000.00. Ten years later the census listed his real estate at \$8000.00 and personnal property at \$3600.00. The 1870 census was the last census to indicate these values.

Washington Quinn was the administrator for the estate of John W. Taylor in 1843. The settlement can be found in box 3 of the probate court records.

John W. Taylor was born May 2, 1815, in DeKalb County, Tennessee. He was the son of Henry H. and Beady Taylor. Henry was a brother of Drury Taylor. John W. married Harriet Quinn about 1840. Harriet was born in Tennessee in 1817. They had one child, a daughter named Lydia Canzatta Taylor, who was born in Illinois in 1841. John W. died on March 4, 1842 in Jefferson County, Illinois.

Harriet Quinn Taylor, who was born in 1817 in Tennessee, and Washington Quinn were bother and sister. She later married Philo Gilbert on August 24, 1845. He was born in 1822 in Ohio. By 1850 they had two children, Eli, born in 1847 and Susan, born in 1849. Lydia was listed as a Gilbert on the 1850 census. She married Robert H. Green in Jefferson County, Illinois, on November 15, 1855. (Fron the Jefferson County marriage records.) They may have moved to Texas County, Missouri later.

After Mary's death Washington remained on his farm, his daughter Sarah lived in the next dwelling as she had done most of the time since her marriage to George Bodine which was in 1860. On the 1900 census Washington was living with Deborah Morgan, his housekeeper. It stated she was married and had been for twenty-six years, had three children, two of whom were still living. She was born in December of 1853 in Illinois, her paretns born in Tennessee. Sometime after this census was taken Washington married her as she was listed as his widow on the probate records of 1903. At this time she listed his property as:

one calf
one hog
one heifer
some other stock
some household and kitchen furniture

worth about \$50.00

As for his survivors, three children were listed: John Quinn; Sarah Bodine; and Onia Dare. Also listed (in a very small space so am not sure of the spellings) were fifteen grandchildren, the children of his deceased children. They were: Odis Quinn, Van Quinn, Rena Sutterfield, Zelda Howell, Clara Quinn, Mabel Quinn, Buelah Quinn, Charlie Quinn, Joseph Quinn, Robert Quinn, Daisy Quinn, Quinn, Kirk Quinn, Julia Quinn, and Earl Quinn.

Twenty-two year old Martha Taylor, called Patsy on the summons, was ordered to testify in a lawsuit filed after her father's death between Abner Caldwell and her mother as administrator for her father's estate. There was no mention of how the lawsuit Abner Caldwell was attempting to collect money owed him from Drury's estate.

Samuel Quinn was one of the appraisors of Drury's estate. At the time he was married and had a couple of children. His wife died sometime between 1846 and 1848. After her death Samuel married Patsy.

Samuel Quinn obtained five land grants in Blissville Township, Jefferson County, Illinois, during the years 1839 through 1852 for a total of two hundred acres. This land was located in sections 27 and 28.

As stated previously there were four Quinns who married Taylors, Mary, Lydia, Washington, and Samuel. The Quinn family was originally from Spartenberg, South Carolina. Sometime around 1815 they moved to Tennessee, county unknown, and in the 1830's moved to Ilinois.

Patsy and Samuel are buried in the Mt. Zion Cemetery in Blissville Township. Samuel died in 1874 when he was sixty-six years old, Martha (Patsy) in 1903 at the age of seventy-nine. Sam and Patsy's grave stones are standing and readable. However there are fourteen other stones in their lot that are broken and cannot be read.

Elizabeth, also called Betsy, was still living at home when her In 1849 she married eighteen year old William father died. Martin Wyatt.

They moved to Ste. Genevieve, Missouri, during the late 1850's and are found on the 1860 Ste. Genevieve Census with her mother and youngest brother. If the census records are to believed they were back in Jefferson County, Illinois, by 1861 when their second child was born, Randall Wyatt. They were still living in Jefferson County when the 1870 census was taken, in addition to their four children, nineteen year old Margaret Minson was living with them. It is believed that she was the daugther of Betsy's youngest sister, Sarah and her first husband, Abram Minson, Sarah died some time during the late 1860's. The 1870 census is the last record that we have found concerning Elizabeth and William Martin Wyatt.

Matthew Taylor was fifteen years old when his father died. apparently lived with his mother for the next ten years. At that time he married eighteen year old Eliza J. Throgmorton, the daughter of William and Lucy Throgmorton. Her younger sister, Mary E. Throgmorton married Matthew's younger brother, Drury M. Taylor four years later.

Sometime after 1858 Matthew and his famly moved to Union Township, Ste. Genevieve County, Missouri. The 1860 Ste. Genevieve County Census indicates that Matthew, Drury M., the Wyatts, and the Thogmortons were all living next to one another.

Shortly there after, at least by 1863, Drury M. and the Throgmortons moved back to Jefferson County, Illinois. However we have no records of Matthew and his famly after 1860.

Matthew and Eliza had two children by 1860, a son whose name may have been Drury and a daughter Mary E.

Duane Marion Taylor, is a Taylor that I've written about previously. At the time he was a man that I believed to be a son of Drury Taylor, Sr. but could not prove. Today I can.

I am including the material that I received from Mary Stanley which can be found in William Taylor, Sr., Volume III. reason for this is to more or less complete the history of Drury Taylor, Sr., all in one format.

Duane was born in 1832 in the hollers of Indian Creek, the ninth of Drury, Sr.'s twelve children. He was thirteen when his father died and was seventeen when the 1850 census was taken. interesting that on this census he was counted twice. the sons of Drury, Sr. had to earn money to help support the family by finding temporary work as farm hands whenever they could. Consequently Duane was found with his mother on the census that was taken in August and with Felix Boswell and family earlier.

I've been told that Felix Boswell's mother was a Taylor, however I have no proof of this nor can I find a tie-in with any of William, Sr.'s family.

Many of the Taylors who had middle names used their first and second names more or less interchangebly, a trait I've never understood, and as a tree climber have never appreciated. It's been hard enough trying to keep track of them when they always used only one name, to say nothing of changing names from one record to another. Such was the case with Duane Marion Taylor. Sometimes he is listed as Duane, with three different spellings, other times as Marion.

When Duane was twenty-three he married seventeen year old Sarah AOnn Simmons in Jackson County, Illinois. One record stated her surname as Rosenburger which is not correct. On the 1880 census Sarah listed her father's birthplace as Germany and her mother's as Tennessee.

Sometime after their marrriage Duane and Sarah moved to Ste. Genevieve County, Missouri, with some other family members. They are on the Ste. Genevieve 1860 census with two children. They apparently moved back to Jefferson County, Illinois by 1862.

From the records of Jefferson County, Illinois, it shows where Duane Taylor gave a warantee deed for his land on March 23, 1872, apparently about the time he left Illinois. It is believed he farmed near Corkery, Missouri, until his death.

Duane Marion Taylor died when he was only forty-seven years old on September 29, 1873, in Leadmine, Dallas County, Missouri. There are two dates for Sarah's death, one has it in 1927 when she was eighty-nine years old, the other on November 2, 1932. They are buried in the Turner Cemetery in Dallas County, Missouri.

The following article is from information that Jake Bains had and was sent to me by Mary Stanley. Mr. Bains used the spelling Dwayne for Duane Marion Taylor. (Another spelling we have found is Duain.)

"Marion's wife, Sarah Taylor known as "Aunt Sally Ann" was a midwife and ERB (herb) doctor. When a baby was to be born she always went a week before due date and stayed. She was a light eater, eating only 1 egg and 1/2 biscuit for breakfast. She entertained the children by telling ghost stories.

"Her husband, Dwayne, shot and killed a man in Illinois, reason unknown. He went to Arkansas to hide. Later joined Sarah in Missouri but according to the 1880 census they had a child born in Arkansas (in 1874). Sarah lived to be very old, age unknown.

"Dwayne Taylor moved to Illinois (some where I got the name Bullknob, Illinois, Union County). Note - Dwayne may be a cousin to brothers Mills and John K. Taylor." (He was a cousin, once removed to the sons of John T. Taylor, son of John (War of 1812) Taylor who was a brother of Drury Taylor. AGT)

Sarah delivered Mary Stanley's grandmother, Ethel May Taylor Wood McNeil Murray, daughter of Mills Taylor. Ethel was born November 19, 1889.

And then from O'Neil R. Tucker's book, <u>The First Seventy-five Years</u>, 1915 - 1990.

"I was ushered into this world by a mid-wife, Sarah A. Taylor. My dad went on horseback to bring her to the little log house.

My brother. Ova says he remembers the occasion very vividly when Dad came with Sarah Ann. She was lovingly called Granny Taylor at that time. Marion and Sarah Ann Taylor migrated from New York to Illinois or Kentukcky. They were of German descent and Sarah's maiden name was Rosenburger. She was Aunt Liz-Scrivener's mother. Sarah Adams' grandmother, and Les, Lena and Err Adams' great-grandmother. I can remember her very clearly. After I got older, she lived with her daughter, Aunt Liz Scrivener, and her granddaughter, Sarah Adams. My rememberance is that she lived upstairs and smoked a clay pipe.

"On December 6, 1921 Granny Taylor was the midwife who ushered my brother, Ralph, into this life as well as she did me."

As much as we would like to believe all the stories written about the early residents of various places, we often find some discrepancies when we check with recorded sources of that time.

So in summary, this is what we do know about Duane M. Taylor. Duane moved with his parents from Indian Creek in what is now DeKalb County, Tennessee, to Jefferson County, Illinois, in the spring of 1841. His father, who was born in Georgia was of English descent, his mother of French descent, born in South Carolina. Duane married Sarah Ann Simmons in Jackson County, Illinois, which is south of Jefferson County. They moved to Ste. Genevieve, Missouri, during the later part of the 1850's and returned to Jefferson about the time the Civil War started. In 1872 he sold his land in Jefferson County and shortly thereafter moved to Arkansas where, according to the 1880 census, Sarah gave birth to a son in 1875, and another in Missouri in 1877. We know that Duane died in Dallas County, Missouri, in 1879.

Mary Stanley of Tulsa, Oklahoma, sent much of the information that I have used in compiling the family tree of Duane Marion Taylor and his wife, Sarah Ann. The additional information has come from Ralph Taylor of Chandler, Arizona.

Sarah Jane Taylor was Drury's youngest daughter. She was eleven years old when her father died. She married twice, the first time when she was only sixteen. She married twenty-nine year old Abraham Minson in 1850. They had two sons, Leroy and Isaiah. We also believe they had a daughter, Margaret. The reason we are not completly positive is that on a later census, her place of birth was listed as Kentucky. Since Abram's mother was born in Kentucky it is quite possible they may have gone to Kentucky for a short time after their marriage. But the main reason we believe Margaret had to be Sarah's daughter was that she was living with William and Elizabeth Taylor Wyatt after Sarah died which was sometime during the late 1860's.

Abram died about 1856 or 1857. His estate was probated in 1857. Abram Minson was the son of William and Jane Minson. Their son William married a Louisa Taylor on August 5, 1861, and another son, John, married Elizabeth Taylor, a daughter of Sarah's brother Duane.

There was an Abraham Minson who received land grants in 1838 and again in 1854 in sections 27 and 28 in Blissville Township for a total of one hundred ninty-nine and twelve tenths acres of land. This was probably Abram's grandfather.

A year or so after Abram's death Sarah married Henry Williams. They had three children, Leander, George, and Henry. Apparently Henry and Sarah both died before 1870 as their three children were living with Sarah's brother John, his wife and his mother, Elizabeth Taylor, when the 1870 census was taken. To date I do not know what happened to the Minson children or the Williams children after 1870.

Sarah and Henry Williams and her sister and husband, Mary and Washington Quinn, were living next to one another in McCellan Township in Jefferson County according to the 1860 census. McCellan Township borders Blissville Township on the west. Two of Sarah's sisters, Rebecca Hicks and Mary Quinn, are buried in the South Hickory Hill Cemetery in Jefferson County and it is quite probable that Sarah is also.

Drury M. Taylor was seven years old when Drury, Sr. died. He was living with his mother when the 1850 census was taken. By the time the 1860 census was taken he was married and living in Ste. Genevieve County, Missouri, close to other family members. This census was enumerated on the 8th of August. Also living with him was his twenty-one year old niece, Elizabeth E. Taylor, believed to be Dempsey Taylor's daughter who was born in Tennessee in 1839. Her occupation was listed as 'serving'.

It appears that at least some of the family moved to Missouri in the late 1850's, however Drury M. was married in 1859 in Jefferson County. Whether he moved after this or not we do not know but he was there by 1860 as were his wife's parents, William and Lucy Throgmorton. Drury's first child was born in Missouri in 1861. There second child, born in 1863 was born in Illiinois. The interesting that they named this boy Jefferson. Did it mean they were very glad to have returned to Blissville Township? Again we wonder if it was the start of the Civil War that made them move back to Illinois.

Drury M. died when he was only thirty-two years old in the spring of 1870. Mary E. Taylor was the administrator of Drury M.'s estate which was settled in 1870 in Jefferson County, IL. She made bond with William C. Taylor on March 19, 1870. This William C. Taylor was a son of Drury's nephew, William Taylor and a grandson of Joseph Taylor, Drury, Sr.'s brother. On a couple of census records he is listed as William T. which later changed to William C.

The probate records did not provide much information other than he died without making a will and had some chattel mortgages. The only ones I have a record of are:

Drury Taylor to Thomas Oard on November 13, 1866 Drury Taylor to George Bullock on October 26, 1867

Mary and her children were living with her parents when the 1870 Jefferson County census was enumerated. Neither Mary, her children or her parents are on the 1880 census of Jefferson County. There is a marriage record for a John R. Taylor marrying a Zelda Rutherford on June 6, 1897, in Jefferson County. I have no way of determing if this was Drury M.'s son or not. The names are the same and the age would be about right.

We have found three different birth years for Mary E. Throgmorton Taylor, 1842 on the 1850 census, 1843 on the 1860, and 1846 on the 1870. I am using her age as found on the 1850 census since she was living at home with her parents, William and Lucy Throgmorten. The Throgmortens came to Illinois from Tennessee about 1838.

John Taylor was the youngest child of Drury and Elizabeth Taylor, being born after they moved to Illinois. He was only four years old when his father died. He and his mother lived together until at least 1870 since that is the last census record we have found for either one of them.

After some of the family had moved to Ste. Genevieve County, Missouri, in the late 1850's, John and his mother were found living with his sister and her husband, William M. and Elizabeth Wyatt as was evidenced by the 1860 census of that county. They moved back to Jefferson County, Illinois, were in 1864 he married Narcena Wells, daughter of L. L. and Clarentine Wells.

At that time he became head of the household as he is found on the 1870 census with his seventy-five year old mother, Elizabeth, and his sister Sarah's children that she had with Henry Williams. At that time John and his wife did not have any children of their own. It is unknown to me if they ever did since we have no trace of him after that census was enumerated.

After doing as much Taylor history and genealogy as I've done for the past thirty years my brain sometimes slips into overdrive. On the 1850 census John was listed as not having a middle intial. However on his marriage record in 1864 he listed himself as John L. D. Taylor. It couldn't possibly be that he added a couple of middle names to make himself John Leander Drury Taylor now could it?? Naaawh, no way!!

I have known for quite some time that there were a few Taylors that had moved to Jefferson County, Illinois, at various times. However we had no idea Drury Taylor, Sr. was also one of them until this past summer.

Some years ago Gary Basden sent me some information concerning one of his ancestors, Mary A. Taylor, who had married Frank Green in DeKalb County, Tennessee, in 1860 and moved to Jefferson County. Mary was the daughter of Isaac Taylor and granddaughter of Joseph Taylor (page 64, Volume III). She raised her family in Jefferson County and in 1883 died there. She was buried in the Panther Fork Cemetery which is located in Field Township.

I had also received information from Mary Stanley that Godfrey Taylor was on the 1850 census of Perry County, Illinois. Perry County is located on the southwest corner of Jefferson County.

Shortly after Volume III came out we learned that Duane Taylor, son of Drury Taylor, Sr. had once lived in Jefferson County. This of course lead us to Drury, Sr. and his family plus a number of other Taylors.

Some time during the early 1850's four of Joseph Taylor's sons left Indian Creek. We eventually managed to find three of them, Joshua, Isaac, and Lewis, but William eluded us. However in studying the 1870 Jefferson County, Illinois, census, Neal Taylor ran across William and his family. We later found where his oldest son, Drury M., married there in 1867 and daughter Sarah in 1869. Whether this family of Taylors remained in Jefferson County or not is unknown. We have not been able to find them on the 1880 census. William's second son, William (T. or C.) Taylor, born in 1848, is buried in Oakwood Cemetery, Mt. Vernon Township, Jefferson County as is George W. Taylor, son of Wilse Taylor and Elizabeth Fish. Wilse was the son of Bully John Taylor and grandson of Joseph Taylor. George W. was married to Effie Spurlock.

We have often wondered why so many of the Taylors left Indian Creek during the fifties. In reading A Bicentiennial History of DeKalb County, Tennessee, by Thomas Gray Webb, I ran across what may have been the reason. There were major floods on the Caney Fork River, one of the first being in 1852. The backwaters also flooded the creeks and hollows and floated away buildings, rail fences, and livestock in the entire area. Indian Creek is one of the tributaries of Caney Fork and was no doubt somewhat devasted by this flood and caused some residents to move to other places and start over.

Henry H. Taylor also had a son, John W. Taylor, who we had not been able to locate previously, but in going through the probate records we discovered he too had moved to Jefferson County. He was married to Harriet Quinn and at his death Washington Quinn

was appointed the administrator of his estate. As has been mentioned previously Washington and Samuel Quinn had each married a daughter of Drury Taylor, Sr. Searching further we discovered that Jacob P. Taylor, son of David Taylor, 1779 had also married a Quinn, Mary (Polly) Quinn.

The elder Quinns, Samuel, who was born in either 1809 or 1811, Mary, born in 1811, and Washington in 1814 were born in Spartenburg, South Carolina. By 1817, when younger sister Harriet was born, they were in Tennessee, couty unknown. Harriet and her husband, Jacob P. Taylor were living in Illinois by 1832 and Samuel was receiving land grants by 1839 in Blissville Township.

Samuel and Washington both died and are buried in Jefferson County. After the death of John W. Taylor in 1842 Harriet eventually remarried Philo Gilbert. I do not know if they remained in Jefferson County or not. Harriet and John W.'s only child, daughter Lydia, married Robert Green and moved to Texas County, Missouri.

Jacob P. Taylor and Mary Quinn and their family returned to DeKalb County, Tennessee, about 1843 where they remained.

There is also a descendant of Samuel Taylor, Sr. living in Jefferson County, at the present time, Samuel, Sr.'s great, great, great, grandson, Delmar Taylor.

There are many other Taylor descendants living in Jefferson County although many of them do not have the surname of Taylor any more. With access to census, marriage, death, probate, and cemetery records much more information could be found in this county by anyone interested in this Taylor family.
